A retired partner in the General Litigation Practice, **Mike Russ** practiced for two years in Washington, D.C. and joined King & Spalding in 1971. He was elected partner in 1975. His practice has focused on corporate litigation, antitrust and SEC investigations, as well as general commercial disputes.

Mr. Russ has served as the partner responsible for many of the firm's important litigation matters, including:

- Lead counsel for Avondale Mills, Inc. in connection with insurance claims and federal court litigation seeking recovery of property damage, loss of income and business value caused by a January 2005 train derailment and chlorine release.
- Lead counsel for Sprint Nextel in affiliate litigation arising out of the merger of Sprint and Nextel.
- Lead counsel for a major textile company in five years of litigation and arbitration arising out of a fire loss that involved sharply contested insurance and construction issues. The client prevailed against a syndicate of 33 insurance companies and recovered one of the largest awards for property damage and business interruption loss ever rendered.

- Represented The Coca-Cola Company as co-counsel in the Coca-Cola/Tri Star securities/shareholders litigation in Delaware Chancery Court.
- Represented Brown & Williamson Tobacco Corporation as co-counsel at trial of a class action brought by airline flight attendants who claimed personal injury caused by environmental tobacco smoke.
